Illuminated push button switch, Type S, followed by 2 or 3, followed by PR or PF, followed by -P3, followed by R, G, B, W or Y, followed by AD, 2AD, BD, 2BD, ABD, AL, 2AL, BL, 2BL or ABL.

Selector switch, Type S, followed by 2 or 3, followed by SR or SF, followed by -S3, -S4, -S5, -S6, -S7 or -S8, followed by W or R, followed by A, 2A, 3A, B, 2B, 3B, AB, 2AB or A2B.

Pilot light, Type L, followed by 2 or 3, followed by PR or RF, followed by -L1, -L2 or -L3, followed by B, G, R, W or Y, followed by D or L.

I/O push button switch, Type S, followed by 2, followed by TR, followed by -P3, followed by W, followed by ABD or ABL.

Begin push button switch, Type S, followed by 2, followed by BR, followed by -P1, followed by G or R, followed by A, 2A, 3A, B, 2B, 3B, AB, 2AB or A2B.

LED Block, Type SA, followed by LA or LD.

Contact Block, Type SA, followed by CA or CB.

Marking: Company name, type designation and electrical rating.
